



1st watershed plan was developed in the late 1800's by John Wesley Powell for the Western States






2002 memo from G. Tracy Mehan

nation's water."



EPA's requirements for a watershed plan

- Identify stakeholders
- Develop goals and objectives for watershed
- Take inventory of watershed resources and current conditions
- Assess waterbody/watershed problems
- Add Section 319 components for pollutant load reductions

EPA requirements cont.....

- Recommend management practices
- Estimate the amounts of technical and financial assistance required
- Develop action plan
- Develop an implementation schedule
- Develop a monitoring schedule for success and criteria for assessment of success

10 reasons that Watershed Plans are important:

- Plans give local stakeholders the ability to have input about local future land use according to their needs. (Grassroots decisions rather than 'top-down' or government decisions)
- An EPA approved plan can be a tool to bring financial resources to the area to accomplish water-protection goals.
- Plans clarify current and future water issues in the region.
- Plans document the intentions of the stakeholders for future leaders
- Plans can take a holistic approach to watershed issues, addressing water quality, stormwater, flooding, aquatic habitat, groundwater and water supply, depending on the priorities of the participants.

10 reasons cont.....

- Plans allow all stakeholders to express their own vision for the region and merge those with other stakeholders.
- Plans allow planning with water resource protection as the foundation, rather than land resources. This is particularly important in regions that depend upon well water.
- Plans clarify community visions
- Plans demonstrate to others that the community vision is important to preserve for future generations
- Plans identify and clarify priority protection areas
